RESOLUTION APPROVING THE CONSENT TO TERMINATION OF ASSIGNMENTS FOR CAPACITY SCHEDULE AND THE AGREEMENT FOR CONSENT TO TERMINATION OF ASSIGNMENTS FOR CAPACITY SCHEDULE

WHEREAS, the Municipal Electric Utility is a joint owner of a generation facility known as Neal Unit 4 ("Neal 4"); and

WHEREAS, the Municipal Electric Utility is a party to certain capacity assignments (the "Assignments") for purposes of physical delivery of Neal 4 output; and

WHEREAS, the Municipal Electric Utility has been a joint owner of Lehigh Webster Transmission ("L-W Transmission") used for the physical delivery of Neal 4 output but recently sold its ownership interest in L-W Transmission to MidAmerican Energy Company ("MEC"); and

WHEREAS, through the Municipal Electric Utility's participation in the Southwest Power Pool, it has preferred alternative delivery paths for its Neal 4 output and the Assignments are no longer necessary or beneficial; and

WHEREAS, termination of the Assignments would avoid ongoing costs under the Assignments; and

WHEREAS, because the Assignments are no longer necessary or beneficial, the avoidance of costs through the termination of the Assignments is necessary and appropriate; and

WHEREAS, the Assignments are with MEC and Interstate Power and Light Company ("IPL"); and

WHEREAS, MEC has agreed to termination of the Assignments in partial consideration for the sale of L-W Transmission to MEC; and

WHEREAS, IPL has agreed to termination of the Assignments in consideration for a lump sum payment to IPL (approximating the present value of four years of payments which would otherwise be due to IPL under the Assignments); and

WHEREAS, the forms of (1) a Consent to Termination of Assignments for Capacity Schedule, and (2) an Agreement for Consent to Termination of Assignments for Capacity Schedule, have been prepared and are now before this governing body; and

WHEREAS, the lump sum payment to be paid to IPL in consideration for its agreement to terminate the Assignments shall be the amount set forth in Section 1 of the Agreement for Consent to Termination of Assignments for Capacity Schedule; and

WHEREAS, payment of said lump sum payment to IPL in connection with termination for the Assignments will produce savings for the Municipal Electric Utility; and

WHEREAS, termination of the Assignments is deemed necessary and appropriate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MUNICIPAL ELECTRIC UTILITY OF LAURENS, IOWA:

## RESOLUTION AUTHORIZING TRANSFER OF SURPLUS FUNDS FROM THE LAURENS MUNICIPAL ELECTRIC UTILITY TO THE CITY OF LAURENS

WHEREAS, Section 384.89 City Code of Iowa provides that the governing body of a City Utility may under certain circumstances transfer surplus funds on hand to any other fund of the City in accordance with any rules promulgated by the City Finance Committee if the transfer is also approved by the City Council; and

WHEREAS, this Board hereby determines, based on Rule 2.5(5) of the rules promulgated by the City Finance Committee in accordance with Section 384.89, Code of Iowa, that the Electric Utility currently has a balance of \$3,955,953, and has on hand available surplus funds of \$2,216,246, after making all deposits into all funds required by the terms, covenants, conditions and provisions of outstanding revenue bonds, pledge orders, and other obligations which are payable from the revenues of the Electric Utility in accordance with Section 384.89, as shown on the Electric Fund surplus calculation attached hereto as Exhibit 1 and by this reference incorporated herein; and

WHEREAS, all the requirements, terms, covenants, conditions and provisions of the proceedings and resolutions authorizing the issuance of outstanding electric revenue bonds and pledge orders have been complied with; and

WHEREAS, this Board finds that a transfer of the Surplus does not and will not conflict with any of the requirements, terms, covenants, conditions, or provisions of any resolution authorizing the issuance of revenue bonds, pledge orders or other obligations which are payable from the revenues of the Electric Utility; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MUNICIPAL ELECTRIC UTILITY OF THE CITY OF LAURENS, IOWA:

Section 1. Pursuant to and in accordance with Section 384.89, Code of Iowa, and Rule 2.5(5) of the rules promulgated by the City Finance Committee, the Electric Utility has surplus funds available for transfer.

Section 2. After investigation not more than \$33,180.00 now on hand is declared to be surplus funds of the electric utility and are not required for current utility operations.

Section 3. Upon investigation, it is found to be necessary, advisable, and in the best interest of the electric utility and its customers that \$30,000.00 be transferred to the City for its use as the City Council shall deem appropriate.

Section 4. Upon investigation, it is found to be necessary, advisable, and in the best interest of the electric utility and its customers that \$3,180.00 be transferred to the City for its use to go towards the purchase of a new John Deere Mower.

Section 5. In accordance with Section 384.89, Code of Iowa, this transfer is subject to approval by the City Council.
